Participant hereby releases, discharges and agrees to hold harmless the Sponsor, the Administrator and their parents, subsidiaries and affiliates, and all of their licensees, successors, assigns, and agents, and the employees, officers, directors, shareholders of the foregoing and those for whom they are acting, from any liability, loss, damage (including consequential damages), costs, loss of services, claims, including without limitation attorney's fees and costs, incurred by any such release that arise from or relate to: (a) Participant's participation in the Contest; or (b) the contents, production, broadcast or use of the Video, or use of any portrait, picture, recording (audio or visual) of him/her or of any scene or sequence in which his/her likeness appears.
